Directors Report

If you are listening to the news, you can hear about the financial struggles that are affecting cities and towns of all sizes, including Wayne County and most notably the City of Detroit. Retirement benefit plans have become a frenzy of focus with the media and many have decided that the pension plans caused Detroit's bankruptcy. Public benefits are easy targets for critics, and the legal issues regarding Federal Bankruptcy and the State of Michigan constitutional protection will likely be addressed in the US Supreme Court.

This is a season of change. The days continue to grow shorter, the fall color tours have come to a close, and despite their best efforts, our Tigers fell short of their World Series goal. We must look forward, though, with hope and anticipation. We take this time of year to evaluate our shortfalls, celebrate our successes, plan for our growth and embrace change. Yes, the brilliant colors of fall have passed, but we know the leaves only lie dormant awaiting the emergence of the warming sun of spring. The recent mayoral election in Detroit has spoken loudly of the need for change. Often times we continue with routine because it is predictable and comfortable. Going Green

With so many retirees choosing to have their direct deposit statements sent to them through email, it has really generated a significant cost savings. We have 2,400 retirees who currently have their statements emailed to them which is saving the Retirement System \$1080.00 per month in postage alone, not to mention paper, envelopes, and labor.

Directors Report

The recent investment performance continues strong and is encouraging. For the year ending September 30, 2013, the investment return gross of fees was 15.01%, the two and three year returns were 15.87% and 9.80% respectively. This is good news for the fund but remember the pension system can be likened to a marathon, not a sprint. The County pensions are currently funded at 46%, and we continue concerted efforts to grow the assets for future pension payments.

Just as a reminder the Retirement Commission does not negotiate or grant benefits; the Retirement Commission is responsible for the **administration** of benefits.

<u>History of Pensions</u>

There is education in our rich history. The United States is the greatest nation in the world because of its willingness to recognize the strengths of the past and initiate change for the future. Public pension benefits were first granted in the U.S. Revolutionary War. In fact, George Washington had to personally intervene to prevent a mutiny of Continental troops over promised pension payments. It started to be common in the late nineteenth century for states and local governments to offer pensions for public workers and became more widespread after World War I.

The Wayne County Employees' Retirement System (WCERS) is a public employee retirement system that was established by the County of Wayne on December 1, 1944. WCERS is administered by the Retirement Commission ("Board of Trustees") to provide retirement, disability, death, and survivor benefits for its employees' under the authority of the Home Rule Charter for the County and Section 12a of Act No. 156 of the Public Acts of Michigan of 1851 (MCL 46.12a, MSA 5.333(1)), as amended.

There are currently more the 2,500 public retirement systems in the U.S. today with over \$3 trillion in assets, covering more than 18 million workers at the federal, state and local level. This is about 12% of the nation's workforce. Each year 8 million retirees receive \$200 billion in pension benefits, for many of these retirees their pension is the backbone of their income, providing them with the ability to purchase day to day necessities, but this money also drives economic activity for the States and local communities in which they live. "Retiree expenditures stemming from state and local pension plan benefits supported 71,894 jobs in the state. The total income to state residents supported by pension expenditures is \$3.0 billion. To put these employment impacts in perspective, in 2009 Michigan's unemployment rate was 13.3%. The fact that DB pension expenditures supported 71,894 jobs is significant, as it represents 1.5 percentage points in Michigan's labor force." (www.nirsonline.org, National Institute on Retirement Security)

Police Officers Association of Michigan (POAM) Arbitration

POAM recently completed binding arbitration, which involved pension changes. Currently, the VanOverbeke, Michaud & Timmony, P.C., law firm and our actuary are reviewing the award so the Retirement Commission can take the appropriate action with regard to any pension changes. An update will be provided in a future newsletter.

Directors Report

Detroit-Wayne County Community Mental Health Authority

On a positive note, WCERS submitted a response to be the retirement administrator for the newly created Detroit-Wayne County Community Mental Health Authority and earned the award over six other respondents, including Municipal Employees Retirement System of Michigan (MERS). WCERS has always been very proud of the Defined Contribution plan we administer, and believe it is one of the best run municipal DC plans in the country. We believe this award reinforces our belief, and emphasizes the importance of a transparent process.

Inflation Equity Fund

The Retirement Commission voted to authorize one million dollars for this year's distribution. The unit value is \$2.12, about the same as last year. This amount was included in the November 1, 2013 payroll.

Office Closings

The WCERS office will be closed the first Monday of each month again for the 2013-14 budget year. Should that Monday fall on a holiday, the furlough day would be observed the Tuesday after the holiday.

Last but certainly not least, I would like to acknowledge and congratulate the former director of the Retirement System, Alfred Bricker, and his wife Lillian Bricker on 66 years of marriage. I hope each year is better than the last. Congrats!
