# THE MESSENGER WAYNE COUNTY EMPLOYEES' RETIREMENT SYSTEM

### **Directors Report**

The system had a positive investment return experience in Defined Benefit Plan investment earnings for the year ending September 30, 2014, the investment return gross of fees was 9.01%, the two and three year returns were 11.97% and 13.54% respectively. This is good news for the fund but remember the pension system can be likened to a marathon, not a sprint. The County pensions are currently funded at 44%, and we continue concerted efforts to grow the assets for future pension payments. In addition the Retirement System is pleased to have come in under budget for the third year in a row. Our budget for the years ended September 30, 2014 and 2013 was \$8,002,000, we spent \$6,717,900 in 2014 and \$5,965,161 in 2013; our budget for 2012 was \$7,502,000 and \$6,145,806 was spent running the Retirement System. I am continuously looking for way to reduce expenditures and streamline the system.

The Retirement System also had two elections. I am pleased to report that Hugh Macdonald has been reelected. He was the only candidate to return petitions for the position of Retiree Trustee and will be returning for another four year term starting January 1, 2015. I am also pleased to report that the incumbent for the position of Active Trustee, Charles Bonza was reelected. He was also the only candidate to return petitions for the position of Active Trustee. All of the election details can be found on our website, www.wcers.org.

Andrea Hutting, Retirement Commissioner, for the last three years and County employee for over nine years in the Prosecutor's office has taken a fantastic opportunity over at the Federal Prosecutors Office. Andrea's zeal for representing the retired and active employees will be missed. The Retirement System is sad to see her go but is very proud to have someone so amazing represent the Federal Prosecutors office. Congratulations Andrea! The special election process will begin in January for her replacement.

Retirees are encouraged to review their federal income tax withholding every year; individuals and couples with multiple incomes, people who are having children, getting married, getting divorced, and those who typically wind up with a balance due or large refund at the end of the year may want to consider submitting a new W-4P Form. IRS Publication 919, *How Do I Adjust My Tax Withholding?*, provides information on making changes to federal income tax withholding. We have provided a W-4P below to request any tax changes, please complete and return to our office.

#### Cyber Security

We would like to remind you to continuously monitor and protect your digital data. Risks are associated with your banking information, social media sites, or email (work and personal). You should protect any related data, account information, user ID's and passwords. Here are some good cyber security practices to keep in mind now and going forward throughout the year:

Never share your account information, user ID's, and passwords with anyone. Be aware of emails requesting personal, account, or other protected information. These are typically phishing emails attempting to extract your credentials or access information.

- Don't post 'Going out of town' or 'Going on vacation to ...' info on social media sites such as Facebook.
- Change your passwords regularly. Create strong passwords by using a mixture of upper case, lower case and numbers.

Monitor your bank accounts and credit cards for unusual activity. Look for small amounts being withdrawn over a short period of time. A series of small, unauthorized withdrawals can lead to a complete emptying of your bank account.

- Don't open or forward emails from unknown senders.
- Don't click on links within emails unless you know the link is legitimate. •

Delete any and all spam without reading it.

#### Year End Office Closures

We will be closed Wednesday, December 24<sup>th</sup> through Thursday, January 1, 2015.

Required Minimum Distributions for Defined Contribution (Plan 4/5) and Deferred Compensation

Beginning in the year you reach age 70<sup>1</sup>/<sub>2</sub> you must take withdrawals, or required minimum distributions (RMDs), from your retirement accounts or be subject to a 50% penalty tax. Exceptions generally include:

**Roth IRAs** 

Your very first RMD, which you can delay until April 1 of the following year, but which would require you to take two RMDs that year

Retirement plans sponsored by your current employer, for which RMDs can be delayed until the year you separate from service

RMDs are taxable, except to the extent they represent after-tax or non-deductible contributions, and cannot be rolled over to another retirement account. Please consult a tax professional to discuss your particular situation. If you are age 70 ½, have a Plan 4 or Plan 5 account with Prudential or a Deferred Compensation account (VOYA, Mass Mutual or AXA Equitable) and have not received a notice about your RMD please contact our office at (313) 224-5890.

#### Retiree Information Verification Forms

You were all mailed forms recently asking you to verify your current address, phone and other pertinent details. The forms were due back to the Retirement office by December 8, 2014, if you have not yet responded you will receive a second notice via mail shortly. This mailing is done as an audit of the retirees in the system and required by the Retirement Board and requires every retiree of Wayne County to respond. Board policy requires us to shut off the pension of any individual that does not respond to the second mailing. If you have not already responded or received our second mailing by the first of the year please call our office.

#### Inflation Equity Fund Litigation Update

Oral arguments were heard at the Supreme Court on October 8, 2014 at 12:15 pm. We now await a decision and hope to hear something before summer. I will continue to keep you updated.

#### Inflation Equity Fund

The Retirement Commission voted to authorize one million dollars for this year's distribution. The unit value is \$2.13, about the same as last year. This amount was included in the November 1, 2014 payroll. The new inflation equity fund balance is \$1,258,097.
